A Pre-bid conference shall be conducted at the PENELCO Main Office at **2:00PM, Philippine Standard Time (PST) on October 17, 2024 (Thursday)**. Sealed proposal must be received by the PENELCO-PBAC at PENELCO Main on or before 2:00PM (PST), **October 31, 2024 (Thursday)**, at which time and place said proposal shall be opened and read in the presence of Bidders or Bidders' representatives who choose to attend. All bids submitted must be accompanied by a **bid security of not less than five (5%) percent of the total bid price**. Late submission shall not be accepted.

The Eligibility Check shall use a non-discretionary "pass/fail" criterion, and the awarding shall be per schedule. All particulars relative to Eligibility Requirements, Examination, Evaluation of Bids and Post Qualification shall be governed by the pertinent provisions of the bidding documents. PENELCO hereby reserves the right to reject any or all bids, to waive any infor malities therein and to accept such bid as may be considered advantageous to the cooperative.
