**ORDER**

To facilitate the evaluation of the *Application* for the approval of the sale of various sub-transmission lines/assets of the National Transmission Corporation (TransCo) to Peninsula Electric Cooperative, Inc. (PENELCO), an ocular inspection shall be conducted by the Inspection Team of the Commission on 17 August 2023 (Thursday) from nine o'clock in the morning (9:00 AM) to five o'clock in the afternoon (5:00 PM).

Relative thereto, PENELCO is **DIRECTED TO POST** this *Order* in a conspicuous place within its premises, and ensure that this *Order* is likewise posted on the bulletin boards of the Offices of the Provincial Governor and Mayors of the Cities and Municipalities within PENELCO's franchise area. PENELCO must also employ other practical means for the public dissemination of the scheduled ocular inspection.

PENELCO is **DIRECTED TO SUBMIT** proofs of its compliance with the posting and public dissemination requirements to the official electronic mail (e-mail) address of the Commission's Central Records Division (CRD) at [docket@erc.ph](mailto:docket@erc.ph), following the requirements under Section 1, Rule V of ERC Resolution No. 09, Series of 2020.

Within five (5) days from the date that the Commission's CRD acknowledges receipt of PENELCO's email for proof of compliance, PENELCO is also **DIRECTED TO SUBMIT** one (1) set of the original or certified true hard copy of said proof of compliance, following the requirements under Section 2, Rule V of ERC Resolution No. 09, Series of 2020.
